How does a charitable bequest work?

Is a charitable bequest right for me?

If you want to leave some or all of your estate to serve the charitable needs of Catamount Film & Arts, you should consider a charitable bequest. Charitable bequests are ideal for individuals who want a simple way to support our mission and good work beyond their lifetimes. Bequests are revocable and don't require that you part with any current funds, so they should have no impact on your retirement planning. And we usually set aside bequests as permanent funds, from which we only spend the annual income.

With a charitable bequest you can choose to give a stated dollar amount, a percentage of your net estate, or even specific assets. We are here to help you plan what works best for you.
